Our Brothers,

We would first like to thank you for your dedication and service to the Order of the Arrow and the Western Region. What you do affects the lives of youth throughout the Region. We would also like to thank you for your patience while we were working through the myriad of details involved in reorganizing the Sections in the Region. Now we can announce the new section alignments and we can all begin the process of implementing this exciting new era in the Western Region.

This reorganization process began when the National BSA Committee commissioned a consultant company to review all facets of the Boy Scouts and make recommendations to help improve operations and help us obtain our goals. A vast number of improvements were presented and as a result there have been and will continue to be changes in the method in which many parts of the BSA operate. That unit in your hometown may not see obvious changes as a great many are administrative, but they should see a continued improvement in programs and service to help them with their local programs. This is where the Order of the Arrow comes in! As part of the organizational overhaul of the Western Region we will have six physical Areas where previously we had only 4. Our Area Directors and Region and National Staff reorganized the areas and those changes have been reviewed and agreed upon by your Scout Executive. The Region Staff then allowed us input on which Councils would be in which Sections and we want like to thank them for that opportunity. Our new Sections were then approved by the Area Directors. The official vote for the realignment by the Western Region BSA Committee will take place in September. However, due to important fall dates such as our Gathering in October, we have been

allowed to announce our changes so that the Section Advisers and Section Chiefs can implement the changes immediately.

This is an exciting time for all of us. We have been given a chance to start fresh in most of our Sections. Some have lost or gained a single lodge while a few have gained or lost more than that. We now will have 14 sections rather than the previous 12. We urge each section to think "outside the box"- for example, just because there were always fall conclaves does not mean your new conclave has to be in the fall.....Now is your chance to take the best traditions of the old sections and combine those with new ideas and create new traditions! Please also remember that we will be getting all new section designations.

We all have much to do. Included with this communication the information you have been waiting for...

So.....attached is:

1. **NEW Western Region Section/Lodge Assignments**- EFFECTIVE IMMEDIATELY FOR THOSE THAT HAVE COMPLETED THEIR 2008 CONCLAVES. There are 4 Sections that have conclaves this fall and the reorganization for them will take place at the end of their conclave. We are aware that means a few new sections will have to wait a bit as some of their new lodges have to complete conclaves. The Section designations on this page are temporary- they are NOT the designations you will end up with.
2. **Section Chiefs and their new Sections.** If you are a chief elected in 2008- which Section are you in?
3. **Section Adviser appointments.** We have communicated with all of our current section advisers prior to this announcement, so to prevent surprises. There are a few whose councils have been moved that will become associate advisers in their new section. We also have some new advisers already appointed where vacancies developed and names for the three remaining vacancies are with the Area Directors for selection approval and appointment. Those remaining three should be appointed within the next 10 days. We know we have not addressed the associate section advisers in every section. It will be important that each Section Adviser work with us to get your Associates approved and appointed.
4. The **Action Plan** for implementation.
5. Map of the new sections.

What do we do now?

1. If your section is one that all lodges have had their conclaves for 2008 then you are a new Section NOW. If even some of your lodges have to complete their 2008 conclave this fall then you need to wait for full reorganization until the completion of their conclave.
2. You need to confirm your Section vice Chief and Secretary. It is possible that you have more than one and if so they will share office until the next conclave and elections.
3. There are 2 Sections that need to elect new chiefs- please ensure before you do that you won't be affected by any elections held in the fall conclaves.
4. If your old section has any conclave finances that have not been finalized from your 2008 conclave you have to have that completed immediately.
5. The Area Directors will need to appoint or reappoint staff advisers for each and every section. Please work with your existing staff adviser until that time. If you do not have a staff adviser let us know and we will work with your Area Director to resolve the issue.
6. Review the Action Plan and begin working immediately on those items not yet complete.

We will schedule a conference call before the end of August for all Section Chiefs, Section Advisers, and Staff Advisers. At that time we will review all the processes involved and work through any unanswered questions. You will receive notice of this conference call shortly.

These changes are exciting and going to take the efforts of all of us to ensure that the transition goes smoothly. Let's have fun with it!

## REALIGNMENT SECTION CHIEFS

Mark Hendricks, Jake Wellman and Mike Bliss reviewed the status of the post-realignment Section Chiefs. We currently have no duplicate chiefs- IE situations where the realignment results in two section chiefs in the same section. ## **2008 Reorganization- Order of the Arrow Sections Action Plan**

### Recommendations and Decisions

- Region OA Chairman and Region Staff Adviser draft section alignments based on new Area configuration
- Section alignment proposal shared with and recommended to the Area Director
- Area Director makes final decision in consultation with Region OA Chairman and Region OA Staff Adviser

### Communications

- Written documentation of Section configuration and plan shared with current Section and Lodge OA leadership
- Conference call with current Section Advisers and/or conference call with current Section Chiefs and possibly all Section Youth officers.
- Section Council of Chiefs by the Section Key Three

### Section Advisers and Section Staff Advisers

- Area Directors to appoint Section Advisers and Staff Advisers for each Section in his Area in consultation with and concurrence by the Region OA Chairman and the Region OA Staff Adviser
- Implementation immediately following the conclave for those Sections who hold conclaves in the fall. Immediately upon approval of plan for all other sections with complete reorganization no later than Dec 31, 2008.

### Section Officers

- All officers will serve in the position in which they were elected in the new section that their home OA lodge is assigned. Their term of office will be until the next conclave.
- Sections that still need to complete their 2008 Conclave will proceed as planned with conclave. This includes normal elections with all current lodges participating. Youth from any lodge in the current section may run for office regardless of the status of their lodge at the end of the conclave. However, no youth shall use the reorganization as part of his platform for office and it is the responsibility of the Section adviser to ensure adherence to this

policy. At no time should the reorganization remove the opportunity for a youth to run for office or vote as provided in the Field Operations Guide.

- A special Council of Chiefs with appropriate advance notice will be held to elect officers for any vacant offices which may be caused by the reorganization. The process will be similar to filling a vacancy caused by election to a National office as provided by the Field Operations Guide. All elected Section Chiefs (through conclave election or the Council of Chiefs election) will be invited to Texas, may run for national office, and serve on a NOAC committee.
- In some cases sections will have co-chiefs, co-vice chiefs, and /or co-secretaries. They will share the duties in that capacity until the 2009 Section Conclave of the new sections.

#### Finance and Calendar

- The current Council of Chiefs will take inventory of Section supplies and equipment and develop a plan for appropriate and equitable distribution of the supplies or other consideration to the future section or sections.
- The Section leadership will be prudent in closing out ALL section finance accounts and funds in sufficient time to ensure compliance with the deadline.
- Remaining funds in section accounts will be distributed before December 31 to the newly reorganized and realigned sections based on the remaining funds being divided by the number of participants each lodge sent to the Section's 2008 Conclave.
- At the specially called Council of Chiefs- a date, service council, and service lodge will be confirmed or selected for the 2009 Section Conclave. A rotation plan for future years may also be discussed and decided if appropriate.
- All Sections that have completed their conclaves in the spring of 2008 are required to finalize any and all financial transactions for that conclave within 30 days.
